ICCA-introduction

- is a set of laws passed by parliament in 2003 Amended in 2019 and 2020
- The overall aim is to protect human health and environment from adverse effects of chemicals

ICCA-Overview

- It contain **63 Sections** arranged in six chapters which cover definitions; administration organs; Management and control requirements; Financial Provisions and Miscellaneous Issue
- There **1 to 10 Schedules** to support implementations'

Chemical under ICCA;

*refer to **industrial** or **consumers chemical** or **chemical product** which may be a substance itself or mixture or preparation whether manufactured or obtained natural excluding **medicines, pesticides, radioactive, food additives** and any other substance that has **therapeutic effects.***
