#### 1. INTRODUCTION

- An Act to provide for the Establishment of the Government Chemist Laboratory Authority; to provide for its powers and functions and to provide for matters related thereto.
- ❖ The Act was established in year 2016 and signed by the President on the 23<sup>rd</sup> September 2016.
- ❖ Government Gazette No. 41 Vol.97 dated 30<sup>th</sup> September 2016
- **❖** Came in operation on 5<sup>th</sup> April, 2017
- The Act has 10 Parts, 56 sections and 5 Schedules

- Establishment of the GCLA as a supreme and referral laboratory of the Government of the URT
- Functions of the Authority: 17 functions as per the Act
  - ✓ Conduct Research, Lab Analysis and advice the Government on matters relating to the functions of the Authority
  - ✓ Regulate Chemical, forensic science and HDNA Labs to ensure compliance with prescribed standards
  - ✓ Conduct inspection for premises or services regulated by the Authority
  - ✓ Registration, suspension or cancellation of chemical, forensic science, HDNA Labs, Industrial Chem & Consumer Chem or chem dealers
  - ✓ Advice the Minister on appointment of inspectors
  - ✓ Make laboratory analysis on issues of public interest





# **\*** Functions and powers of the Board:

- ✓ Make guidelines, rules and orders to facilitate implementation of the Act
- ✓ Exempt payment of any fees for the services rendered by the Authority
- ✓ Approve fees payable for the services rendered by the Authority
- **√** .....

The Board may delegate its functions to the CGC, Committee of the Board or employee of the Authority.

# **❖** Appointment, Functions and powers of the CGC

Appointed by the President of the URT amongst public servant. The functions of CGC:

✓ Registrar of Chemicals under ICCA, Registrar of Chemical, forensic science & HDNA Labs – issue registration certificate upon approval of the Board.





## **Appointment of inspectors**

- ✓ Appointed by Minister upon advice of the Board
- ✓ Inspectors appointed under ICCA, HDNA Regulation Act are deemed to be appointed under this Act

#### **Powers of Inspectors:**

- ✓ To enter any premise dealing with services regulated by the Authority for proper performance of such duty or making inspection
- ✓ Issue directives after inspection on areas requiring correction
- ✓ Order temporary closure of the premise pending correction or Boards directives
- ✓ Seize anything or property used in the commission of an offence
- ✓ Upon Board approval impose fines on several offences at such rates as may be determined by the Minister
- ✓ In collaboration with any other Authority, supervise proper disposal of samples, chemicals or any article regulated by the Act.
- ✓ Where necessary, with assistance of Police, arrest any person





## **Powers of Inspectors:.....**

- ✓ Provide advice or recommendation on the proper implementation of the provisions of the Act as per the practice
- ✓ Adduce evidence before the Court

## **Regulation of Laboratories:**

- ✓ A Chemical, forensic science or HDNA Laboratory shall not offer lab. Services without being registered
- ✓ A Chemical, forensic science or HDNA Laboratory shall not be registered unless it has staff who possess relevant qualifications, laboratory with facilities that meets standards prescribed in the Regulation.
- ✓ The CGC shall conduct or cause to be conducted inspection of laboratory by Gazzetted inspectors
- ✓ Owner of Laboratory shall keep records of services offered, recommendations from the previous inspection, if any; and submit to the Registrar twice per year





# THE GCLA ACT. REGULATIONS, 2017

#### 1. INTRODUCTION

- These Regulations were made under section 44 of the GCLA Act.No.8 of 2016
- ❖ Gazette of the URT No. 19 Vol.98 dated 12<sup>th</sup> May, 2017
- ❖ Government Notice No.212 published on 12<sup>th</sup> May, 2017
- ❖ The Regulations has 5 Parts, 27 Regulations and 16 Schedules





#### PART IV: REGULATION OF LABORATORIES

## **Qualifications and functions of Laboratory Staff:**

- ✓ Laboratory Manager At least a BSC. Degree majoring either in Chemistry, CPE, Toxicology, Forensic Science, Environmental Science, FST, Human Nutrition, Lab.Technology or any other related discipline from accredited institution.
- ✓ An Analyst with BSC. Degree majoring either in Chemistry, CPE, Toxicology, Forensic Science, Environmental Science, FST, Human Nutrition, Lab.Technology or any other related discipline from accredited institution





## **Standards for Laboratory:**

Every Lab shall be required to meet the following minimum requirements:

- ✓ A premise of facility which allows operations of the intended lab. Services
- ✓ Adequate Lab. equipment to allow lab analysis to be undertaken according to the scope
- ✓ Adequate space and conducive environment to allow lab. Analysis to be undertaken without compromising quality of results
- ✓ A known physical address secured and easily accessible; have necessary utilities to ensure quality of services, health & safety; have emergence response plan including EHS management systems.

Every registered laboratory shall have QMS in place
